**PROJECT DESCRIPTION:**

Kampala – Entebbe Expressway is a 52Km long dual 2 lane carriageway that starts at the Busega junction on the Kampala Northern Bypass and terminates at Entebbe International Airport. It also included the construction of a 13Km long spur from Kajjansi to Munyonyo. The Project was executed under the Design and Build Contract.

**DESCRIPTION OF SERVICES PROVIDED BY ATRO E&M:**

Our main objective was to assist UNRA in project administration and management. We were responsible for;

1. Monitoring and reviewing the design, construction, testing, commissioning, and completion of the construction works by means of auditing and review

2. Carrying out routine checks on both the supervision consultant and works contractors' operations and management systems. Specifically monitor, administer, and manage the Design and Build Contract ensuring that the Supervising Consultant and Works Contractor fulfill their contractual obligations and adopt international best practices in project implementation
3. Carrying out design reviews
